- (f) that the animal will wear an appropriate collar and identification tag at all times with the contact details of its owner;
- (g) that in the case of cats, that a bell will be attached to the collar;
- (h) that consultation will be made with vet or animal psychologist if the animal displays behavioural problems;
- (i) in the case of dogs, that the animal will at all times when on common property be supervised and under control of a responsible person;
- (j) that the conduct of the animal (including but not limited to noise made or caused by the animal) will not interfere with the security, peace or enjoyment of any Owner or Occupant, any of their guests or any other animal on the common property;
- (k) that the conduct of the animal will not directly or indirectly cause or result in any actual or perceived imminent threat of any harm or injury to any person or animal;
- (l) that the owner of the animal will clean up hygienically after the animal at all times.

**I / We understand and agree to indemnify the Owners Corporation and its employees, agents and representatives, and keep them indemnified, against all of the following:**

- any and all direct and/or indirect damage, harm or loss, or injury to any property or person (inclusive of consequential damage, harm or loss); and
- any medical, veterinary and legal and emergency expenses and costs and disbursements;
- arising directly and/or indirectly from or associated with or consequent to the conduct of the animal and/or its owner and/or the failure of the owner to comply with these Guidelines.
